Part 1: Code of Conduct

All athletes travelling to a competition on behalf of a sport governed by the Manitoba Wheelchair Sport Association (MWSA) shall act in a conduct that is consistent with MWSA's Code of Conduct Policy, and in such a manner that portrays a positive image of the Association. As outlined in Part 6(d) of the Code of Conduct Policy, team specific policies and requirements may be established during the trip and as such, athletes are expected to abide by these requirements.

Any athlete that fails to adhere to the Code of Conduct policy shall be referred to disciplinary action from the Association.

Part 2: Costs

The Manitoba Wheelchair Sport Association (MWSA) shall not cover costs that are not pre-approved by the Association prior to travel. Additionally, funding support from MWSA may not cover the entirety of the tournament travel, therefore, athletes will be expected to cover any costs that are incurred. Any costs arbitrarily chosen by the athlete shall remain the full responsibility of such athlete.

MWSA will properly notify the athlete of their funding support for travel in advance of the trip – allowing for the athlete to make an informed decision.

Part 3: Travel Waiver

I understand that participating in a competitive sport event is a potentially hazardous activity. I should not enter any competitive sport event unless I am medically able. I hereby certify that I am in good health and assume all risks associated with participating in the competitive sport event.

I understand that travelling in a motor vehicle, train, or passenger aircraft can be hazardous. Such hazards may result in personal injury or damage to my personal property. I voluntarily assume full responsibility for any risks of loss, property damage, or personal injury, including death that may be sustained by me, or any loss or damage to property owned by me, while travelling to a competitive sporting event.

I understand that the Manitoba Wheelchair Sport Association maintains insurance coverage for injuries at a sporting event for all valid members. Additionally, the Manitoba Wheelchair Sport Association shall ensure proper insurance of any vehicle that is specifically arranged by the Association. I understand that it is my full responsibility to ensure that the policy coverage is sufficient for my or my child's needs. In the event that the insurance coverage is not appropriate, it is my full responsibility to ensure adequate coverage for my child or myself.

I understand that the Manitoba Wheelchair Sport Association is not responsible for any injuries or loss sustained while travelling in a passenger vehicle that is not arranged by the Association.

In consideration of the above, I hereby release the Manitoba Wheelchair Sport Association, the Board of Directors, their officers, agents, partners, volunteers, and employees from any and all liability, claim, demands, actions, or causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or any of the property belonging to me, whether caused by the negligence of the releasees, or otherwise, while participating in such activity, or while travelling to such activities.
